MUSIC AT JERUSALEM UCC 2020

As I complete my 47th year of music ministry, this past year – 2020 – has unquestionably been the most unusual.

Early 2020 rolled out with our normal schedule of Sunday 9:00 Contemporary services and 10:30 Traditional services. God's House Band, with Bob Fahringer, Lynn Mastio Rice, Paul Rice, Kelly Heinick and myself, led the music for the early service. Our Senior Choir led the later service musically. Our Music & Worship Committee (Lana Kuehner, Donna Mackes, Pastor Kathryn, Bob Fahringer and myself) met in February to plan the season of Lent.

The covid pandemic first impacted us in early March when, for the safety of our congregation, services were cancelled beginning March 15. Choir rehearsals were cancelled and did not resume for the remainder of 2020. Services moved to an online format thanks to the fast work of Pastor Kathryn and Bob F. One service per Sunday was offered via Facebook Live.

In early summer, it was decided by leadership that measures could be put into place that would allow Sunday services to be safely held outdoors in our grove. This required significant planning and activity that had to be done quickly, particularly in light of Pastor Kathryn's sudden departure for a sabbatical. Jennika Borger stepped forward and graciously offered to lead the services throughout the summer and early fall. Equipment was purchased, including a new portable keyboard from Grafton Piano/Organ, Souderton, a radio transmitter, and other items that would allow us to project the services live in the grove and also via Facebook Live and through car radio on 95.5. All equipment was stored in Ryman Hall and the kitchen, and brought out each Sunday for use. It was decided that a blended format would work for these services, with Contemporary songs as well as traditional hymns. This format continued to be used through the end of 2020 and to date.

We wished our wonderful Kelly Heinick all the best as she left for college in the Fall, and we welcomed Stephanie Ryan to step into her place in the band. We have been so fortunate, through Lynn Mastio Rice's contacts, to have a second singer in place every Sunday. Renee Mowad has stepped in when Stephani needed to return her attention to her full-time work as a teacher, and we love having Jillian Rossi with us at present. Pastor Bill Ellsworth returned to preach for us one Sunday, and we welcomed Pastor Don Quayle as our Interim Pastor.

As the weather turned colder, we bundled up and continued our outdoor services until the second week in December, when we moved into the sanctuary. Safety measures were again put into place so that the options of in-person, Facebook Live and radio access were available.

Our plans for an outdoor Christmas Eve candlelight service were changed by bad weather, so instead we held two services in the sanctuary. We received many comments on these simple, lovely services of music and the word.

The monthly visits and services at The Palmerton by Lana Kuehner, Andrea Lazicki, Pastor Ginny Heimer and me took place in January and February, and have been on hold since.

On reflection, it has been a year of change and some loss, but a year of unexpected blessings as well. The weekly services in the grove took on such life, with MANY people commenting on how much they loved worshipping outside. It became almost a challenge to see how long we could withstand the chilly weather. Consistory plus Music & Worship Committee will take a look at this in 2021, and see how we can continue to make best use of our beautiful grove. Our awesome God and His awesome people absolutely stepped-up week after week to plan and put together our services at a time when everything was in a state of change. Special thanks to Lynn Mastio Rice and Paul Rice for all they've done and continue to do. And also, to Ed Brader, Rick and Steph Anderson, Charlie LaSala and ALL others who spent hours setting up each Sunday and tending to the many details. Our Interim Pastor Don Quayle has been so supportive and helpful, and we are grateful to have him with us. We look forward to the things we miss, like Choir and our annual traditions and activities, but know that it has also been a year of learning and discovering new strengths in the face of a challenging time. Thanks and blessings to all who are a part of our UCC family.

Christian Education Annual Report 2020

In the year 2020 we served a total of 17 children in the Sunday/Nursery school programs. Within that 17, 4 children are from Nursery. This number accounts for time between January 2020-March 8th 2020. Two students were to start Confirmation in September but the program was not started due to COVID and the Pastors Leave of Absence.

This was a very strange year with COVID as we could not have in —person Sunday School effective March 15th. While we were quarantining and the church was solely on-line, Bible stories were pre-recorded for the Nursery aged kiddos and a YouTube link of the stories were emailed to the families. That stopped once church was held in-person in the Grove. Zoom classes were held for Sunday School kids. The Confirmation aged students were invited to participate in the Zoom classes.

We did not offer a Nursery Program from March 15 through the remainder of 2020. There were 9 Sunday School children who participated in Zoom which did include one Confirmation aged student. The Zoom sessions were run by a Sunday School teacher and on a few occasions, some of the children actually had charge of the Zoom sessions and, with guidance of their parent, taught the Zoom class. The kids who ran the Zooms indicated that it was a great experience. Zoom classes were held every Sunday throughout 2020. Bibles were delivered to children who needed the Deep Blue Bibles to participate in the Sunday School class. Each week the lesson plan, activity sheets and video link as well as the Zoom link were sent to families of Sunday School kids, so a parent/grandparent could actually teach the lesson to their child/grandchild in the event the child couldn't attend the Zoom class.

Due to COVID and social distancing recommendations, we did not have VBS or a Christmas Program.

2020 ANNUAL TREASURER'S REPORT

On January 1, 2020, we started our books with a balance of \$32,014.78. At the end of 2020, we had a balance of \$34,194.20. While we weren't able to have any of our normal fundraisers in 2020, we still maintained our balance, due to the generosity of our members. We also applied for and received \$22,800.00 in PPP funds in the first round of the program in the spring of 2020. Even though that didn't cover all of our lost fundraising, it went a long way toward helping us meet our budget.

We also contributed to some of our local charities, same as last year. We gave funds to CACPAC, Valor House, Family Promise, and also started our JUCC Family Pantry. All of these organizations were very grateful for our support.

Between October, 2019 and December, 2020, we collected over \$6,000 in contributions towards our Family Pantry. We spent over \$4,800 for Family Thanksgiving Dinners (2019 & 2020) and Christmas Dinner (2020), plus Food Drive-Thru's in March and May, 2020. We served over 150 families since we began this mission. We will be doing another Food Drive-Thru in the beginning of March.

Our Building Fund started out with a balance of \$592,130.26, and ended the year with a balance of \$812,646.79. We received a total of \$241,545.03 in income during the year (gifts, bequests, interest, and investment income). We spent \$21,028.50 this year on our building project (mostly engineering & architect fees). We had a very generous bequest from one of our members who passed. We are very grateful for her gift.

Our Maintenance Fund started out with a balance of \$1,791.14, and ended the year with a balance of \$2,187.14. We received \$2,496.00 in contributions this year, and spent \$2,100.00 on maintenance items. We completed some roof repairs, did some landscaping, and had some painting completed.
